The background of the photograph should be plain and in white, light blue or light pink. Please do not use fluorescent or gradient colour as the background. The photograph should be taken within the last six months. For better printing quality, please use photofinishing paper. Photo printing by inkjet or laser printer should be avoided. LD reserves the right to adjust the image on the photograph.						

Statement of Purpose for the Collection of Personal Data

Purpose of Collection

1. The personal data and other related information provided by means of Form LAB/E1/2025 ("the Form") will be used for purposes relating to the 2025 Labour Advisory Board ("LAB") By-election of Employee Representative. The provision of personal data and other related information by means of the Form is voluntary. However, if you do not provide sufficient and accurate data, the Labour Department may not be able to process the nomination of candidate(s) from the employee union to run for the 2025 LAB By-election of Employee Representative.

Classes of Transferees

2. The personal data and other related information provided by means of the Form may be transferred to other divisions of the Labour Department, other government departments / bureaux / organisations for the purposes mentioned in paragraph 1 above.

Access to Personal Data

3. You have a right to request access to and correction of the personal data and other related information as provided for in Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong). Your right of access includes the right to obtain a copy of your personal data provided by the Form.
